Bob converted two lights to portability for feasibility study.
It was well received and in fact the connectors were improved!
Jim Miles will assist Bob with the lights. The plan is to move the lights during glider operations for wingtip clearance.
 4. Hanger
Ralph Wentzel, Bill Vickland, and Joe Rees.
This one is crucial. We need this for the glass ships and would be nice for the others. Also important to attract more private ship owners.
Spencer presented his quonset hut plan. This is the only viable plan so far. We need to get this coordinated with the Front Royal Airport Commission immediately so we get on the Master Plan.
- IV. ELECTIONS will be held at the March meeting. Nominations were made at the February meeting and nominations will be in order at the March meeting. The attorney says we must elect now.
